## **Food Technology**



Technology helps farmers boost their production. Technology also helps manufacturers process food to suit various needs, and it helps food distributors store and transport food quickly and safely. All these factors make more food available for you. Thus, technology increases your food choices.

For example, poor soil or growing conditions that might limit crop yields are not a problem on farms that use the (1) method of growing vegetables. This technology involves planting vegetables indoors in a nutrient-rich solution rather than in soil. Another technology breakthrough has resulted from scientific discoveries about (2), which are the blueprints in living cells that carry information about specific traits. Scientists and farmers have applied this technology to develop foods with the most desirable qualities.

Once food is produced, the next step is (3), which includes methods of preparing and handling food for safety, nutrition, convenience, and appeal. A major goal of people who work at this stage of bringing food from the farm to the table is to lengthen (4), which is the length of time foods stay safe and appealing to eat. In addition to the standard methods of accomplishing this—freezing, canning, and drying—some companies pass food through radiant energy to kill some forms of disease-causing bacteria. This high-technology method of preservation is called (5).

Often, substances are added to foods during processing to make them safer, more appealing, or more nutritious. The added substances are called (6). Some of these substances increase nutrition value through (7), which means adding back nutrients lost during processing. Other substances are used for (8). In other words, these substances add nutrients that aren't naturally present in the food. Both the food industry and government share responsibility for the safe use of these substances. The food industry researches the safety of a substance. The (9), a government agency, evaluates the research results.
